- Sheriff Bobby Shultz and Bobby Crosby– Vehicle/Pedestrian Safety at Hwy 129 and CR 342 Sheriff Bobby Schultz was present to discuss the pedestrian safety at Hwy 129 and CR 342. Several phone calls to DOT and County Administrator Bobby Crosby. Mr. Crosby was present to discuss a grant available by the state. DOT asked for us to present the project. Mr. Crosby stated that he had asked the county engineer, Greg Bailey of North FL Professionals to look at the project. Some suggestions Mr. Crosby made are possible lights flashing with pedestrian crossing signs. Mr. Crosby stated that there are no match fees for the grant. Some of the expense would be electric for the lights and maintainance. Grant application has to be submitted in March. Mr. Crosby stated that he had spoken to Scott Akins, owner of Akins BBQ. Mr. Akins was present and stated that he is ok with whatever safety precautions needed for the kids to cross safely.

Informed the Council of proposed House Bill 7059 from the State, requiring all city elections to be held with the general elections. This will take the power away from the Town of Bell to set their own election dates and giving the power to the Supervisor of Elections.
